Please understand, we do hundreds of guns every month and we really need your help with these simple rules:

Shippers, Document & Package: Please include a legible copy of your FFL, DL, or ID with your correct physical address, phone, and e-mail. Use this page (or your own) to include **ALL** customer and firearm info and place it in an envelope on the **OUTSIDE** of the box. Why? Some customers do not want us opening their boxes. However, ATF requires that we enter items within a timely manner. Please **DO NOT** ship any items or boxes with any kind of messy packing peanuts or shredded paper. This creates a mess when customers open and inspect their packages. Thank you.

Customers, Track & Plan: Please get tracking numbers and track your own shipments. Please **DO NOT** call and ask if your package is here. (We get so many we won't even know.) **AFTER** you see that your box has been delivered, you may pick it up the **NEXT BUSINESS DAY**. (We need time to enter it.) We are happy to hold items for 30 days for you. Because most of the ATF, FFL, and CBI fees do not go to us, you must **PAY IN CASH**. Background checks can take a while so please arrive at least **ONE HOUR PRIOR** to closing. If you are traveling a great distance, call ahead and make sure we are open that day, and that background checks are going through, and that we will have enough time. Thank you.
